## RULES & REGULATIONS

- Entry must be received by Friday, November 18, 2016 or before the 90-entry capacity is reached
- All parade entries must be family-friendly or will be subject to removal from the parade line-up
- Trailers/Floats with children under the age of 16 must be accompanied by at least two adults (age 18 or older) per each axle of the float/trailer as spotters; towing vehicles (such as a pick-up truck) must have at least one adult (age 18 or older)
- Standing in a moving vehicle or on moving trailer/float will NOT be permitted
- Trash may **NOT** be disposed of in the streets, line-up/loading areas or unloading area/W.J. Carroll
- Each operator of a towing vehicle is responsible for seeing that their float/trailer is properly secured
- Any vehicle operator must obey all laws for proper operation of a motor vehicle
- Any vehicle operator or parade participant failing to follow these Rules & Regulations may be subject to a fine and/or ticket
- Applicants agree to maintain a policy of insurance to cover any negligent omission or negligent act committed by applicant or participants in applicant's parade group during the Daphne Christmas Parade.

*The applicant, in exchange for the right to participate in the Daphne Christmas Parade, agrees to indemnify and hold harmless the City of Daphne and related entities, all agents, employees and volunteers of said organizations free, safe and harmless from any and all claims or expense of whatever kind or nature arising from activities as a parade participant of the undersigned organization and any of its representatives or individual participants. This indemnification and hold harmless agreement shall be governed in all respects under the laws of the City of Daphne and the State of Alabama.*

*Your signature affirms that you have read and understand the aforementioned parade rules, insurance conditions, and you agree to abide by these rules and all City ordinances.*
