ORDINANCE 2005- 40

An Ordinance Appropriating Funds

Ecumenical Ministries Inc.

WHEREAS, Ordinance 2004-31 approved and adopted the Fiscal Year 2005 Budget November 1, 2004; and

WHEREAS, subsequent to the adoption of the Fiscal Year 2005 budget, the City Council has from time to time determined that certain additional appropriations are required and should be approved and made a part of the Fiscal Year 2005 budget; and

WHEREAS, the Ecumenical Ministries Inc provides certain quality of life services, including but not limited to emergency aid and home repair, to the citizens and residents of Daphne.

WHEREAS, the City of Daphne supports the efforts of Ecumenical Ministries Inc in meeting the needs of low-income individuals residing in Daphne.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Daphne, Alabama, that:

- The Fiscal Year 2005 Budget is hereby amended to include a 1980's CDBG Repayment Fund appropriation in the amount of \$ 5,500 to Ecumenical Ministries Inc for the purpose of assisting with such costs as are necessary to provide services including, but not limited to, emergency aid and home repair to the citizens and residents of Daphne.
- The Mayor is hereby authorized to execute the agreement as attached hereto and made a part hereof.
